Summary: To authorize a change in the use of the one percent (1%) local sales and services tax in the unincorporated area of Black Hawk County, Iowa effective July 1, 2026.

The use of the one percent (1%) local sales and services tax shall be changed in the unincorporated area of Black Hawk County, Iowa effective July 1, 2026.

PROPOSED USES OF THE TAX:

If the change is approved, revenues from the sales and services tax shall be allocated as follows:

Fifty percent (50%) for property tax relief.

The specific purposes for which the revenues shall otherwise be expended are:

Fifty percent (50%) for secondary road capital improvements, road and bridge construction, and maintenance.
