	<p>Constitutional Amendment Question</p> <p>Shall the following amendment to the Constitution be adopted?</p> <p style="text-align: center;">1</p> <p>Summary: Provides for only U.S. citizens aged 18 or older and meeting state and county residency requirements to vote in all elections.
